**WHAT IF I CHANGE MY MIND AFTER I SUBMIT MY APPLICATION FOR COLLEGE CREDIT?**

If you enroll for college credit and then change your mind, you must notify FM to cancel your college enrollment. The date you notify FM will determine if you will be responsible for payment.

- You may drop the course and receive a cancellation of your tuition bill if you contact FM by March 1<sup>st</sup>, 2020.
- After March 1<sup>st</sup>, you will be responsible for tuition payment, even if you have not already paid the bill.
- For half-year courses, you may withdraw from a course and receive a grade of “W” (withdrawal) between March 2<sup>nd</sup> and May 3<sup>rd</sup>. You will still be responsible for tuition payment.
